



Child Transportation Agreement

Bendora Support Services charges a minimum of \$40 for transportation of children to and from visits. This amount is charged per visit. The fee includes transport for **up to 3 children** and **up to 50 km** of travel. Please note that the same fee still applies even if the total kilometres per visit are less than 50 km.

Travel begins from the pick up location when the child/ren are handed over to the supervisor prior to the beginning of each visit and ends when the child/ren are handed over to the residential parent after the conclusion of each visit. If any visitation session incurs more than a total of 50 km of travel, each additional kilometre will be charged at \$1 per km.

The \$40 transportation fee will generally be added onto each visitation session invoice and must be paid in full prior to each visit occurring. Charges incurred from any travel kilometres exceeding the 50 km included in the fee will be invoiced following the conclusion of each visit and must be paid in full on or before the specified due date on the invoice. Failure to pay may result in future services being suspended until payment is received in full. Such incidences will also be recorded in all relevant reports and legal representatives may be notified.

Bendora Support Services decides whether it will provide transportation on a case-by-case basis. If Bendora Support Services assesses your case as being suitable to provide transportation services, it is the residential parent's responsibility to provide all necessary car seats and other accessories if required and/or required by law (if requested by the supervisor). Failure to provide adequate car seats and/or other necessary accessories (if requested by the supervisor) may result in the visit being canceled due to the supervisor being unable to safely transport the child/ren. In this situation, the full visitation session fee and transportation fee will still apply and will be credited to the next session.

Please note that Bendora Support Services is unable to allow parents to travel in their vehicle with the children at any time for safety reasons - only the children can be transported by the supervisor. It is the parent's responsibility to get themselves to and from the location/s (including when the location changes, when there are multiple locations to attend etc). Bendora Support Services also does not allow supervisors or children to travel in the non-residential parent's vehicle at any time.
